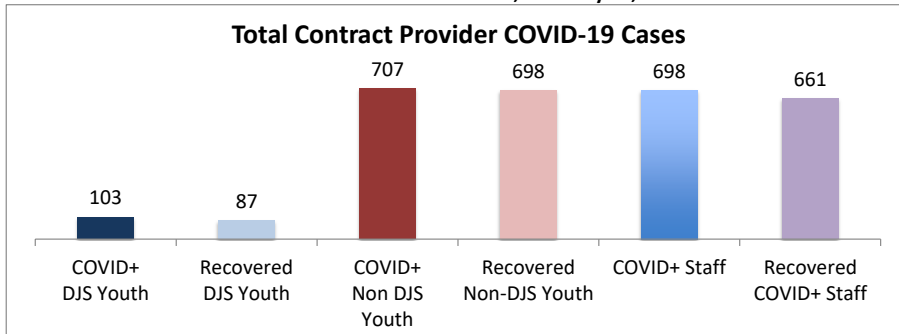


**Overall COVID19 Cases To Date, February 18, 2022**
