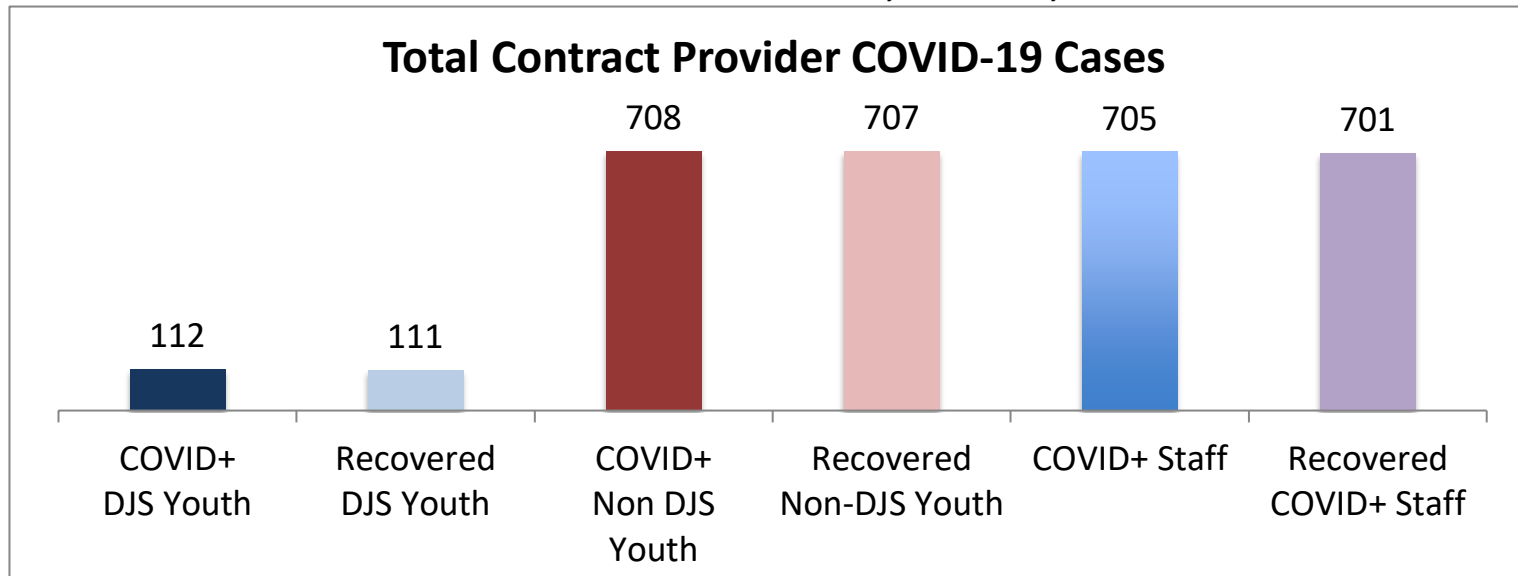


Overall COVID19 Cases To Date, March 17, 2022
