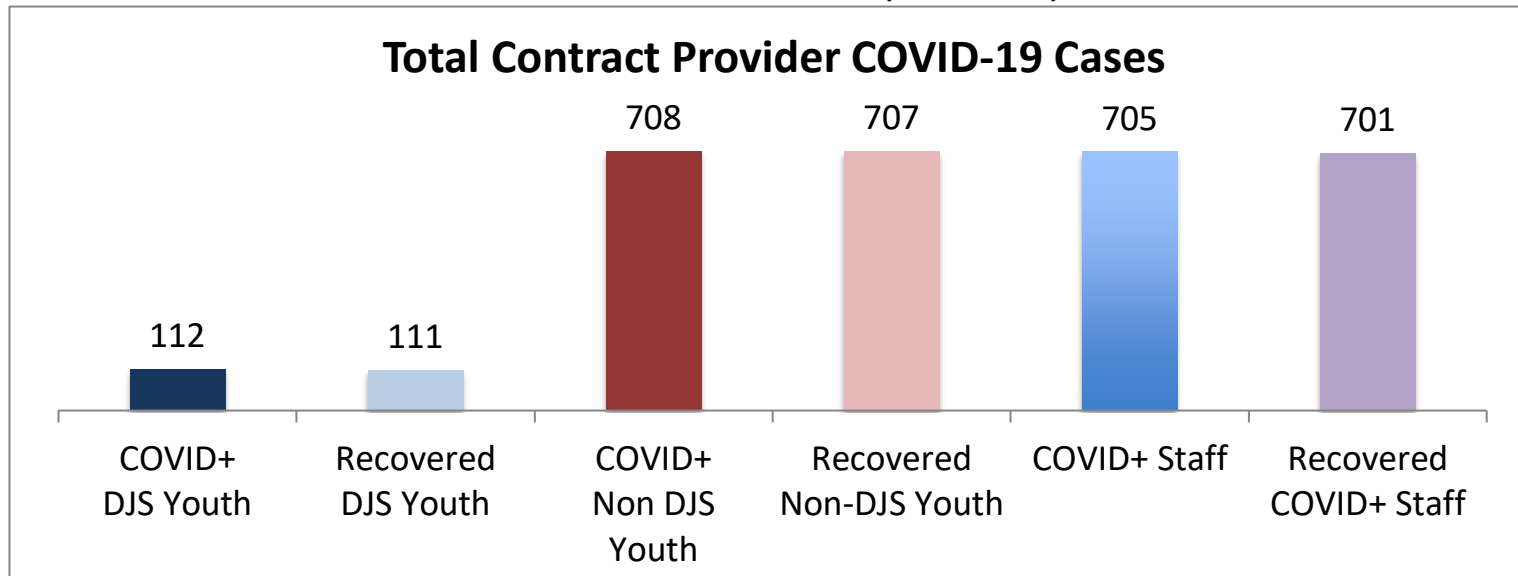


Overall COVID19 Cases To Date, March 18, 2022
