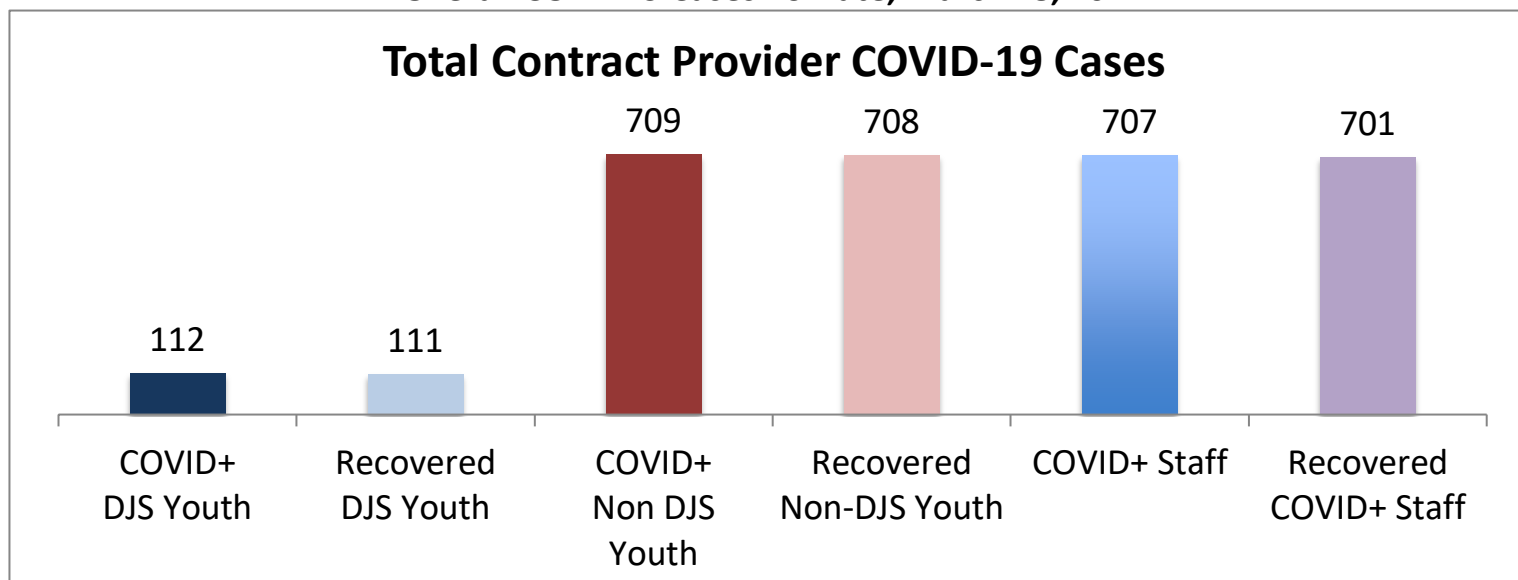


Overall COVID19 Cases To Date, March 28, 2022
