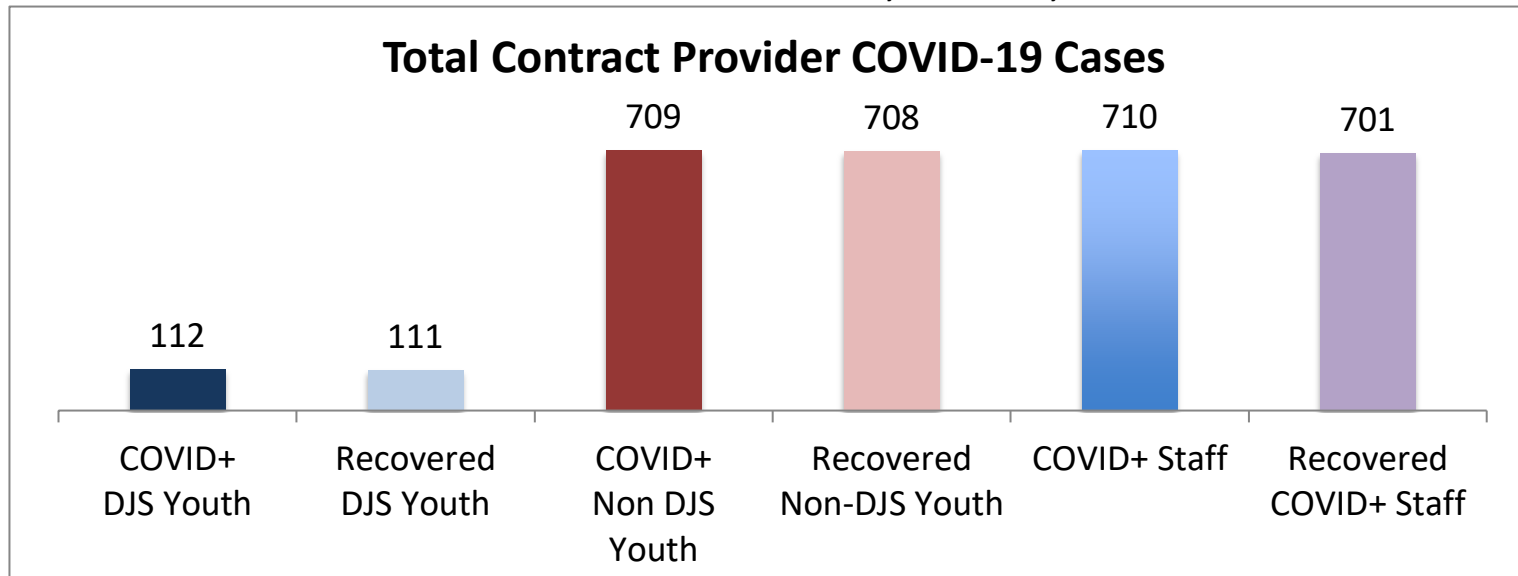


Overall COVID19 Cases To Date, March 30, 2022
