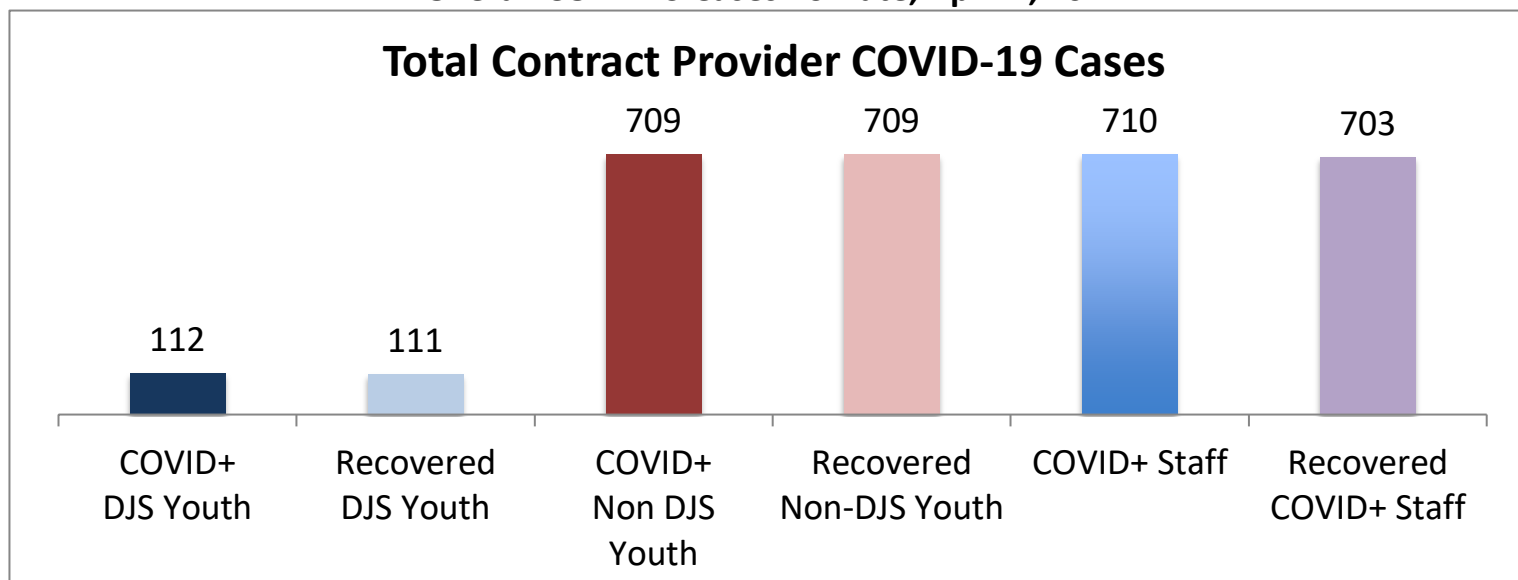


Overall COVID19 Cases To Date, April 1, 2022
