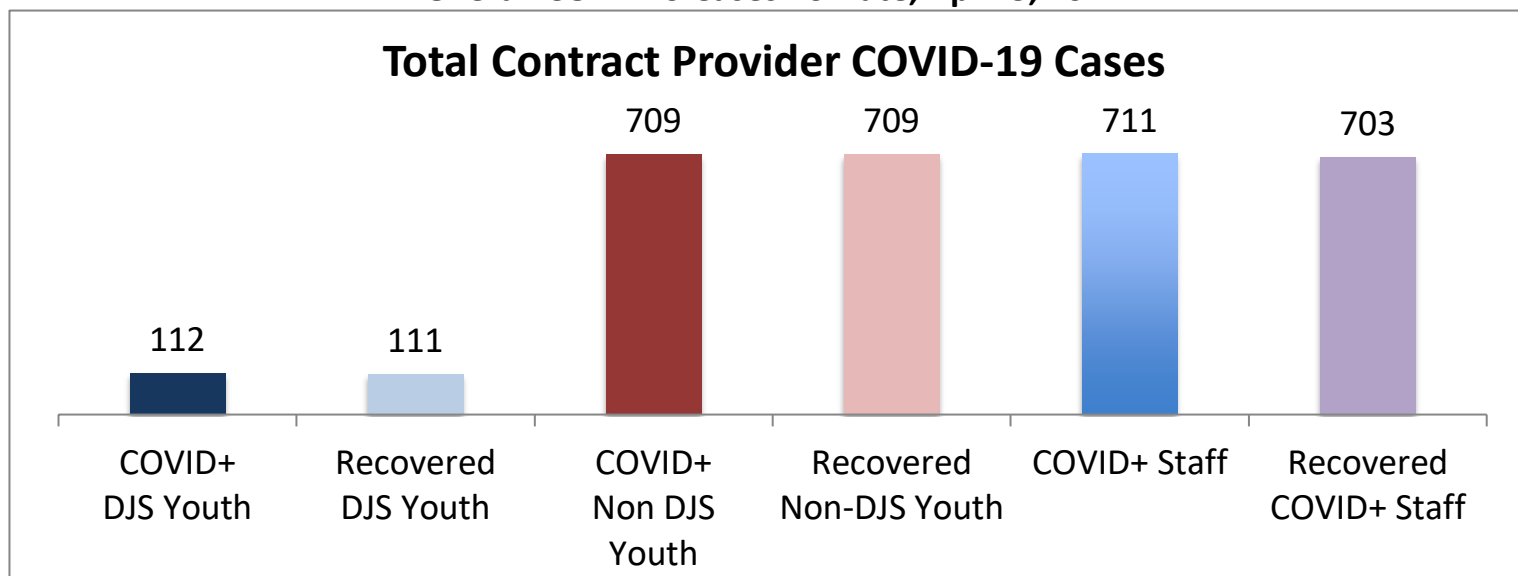


Overall COVID19 Cases To Date, April 5, 2022
