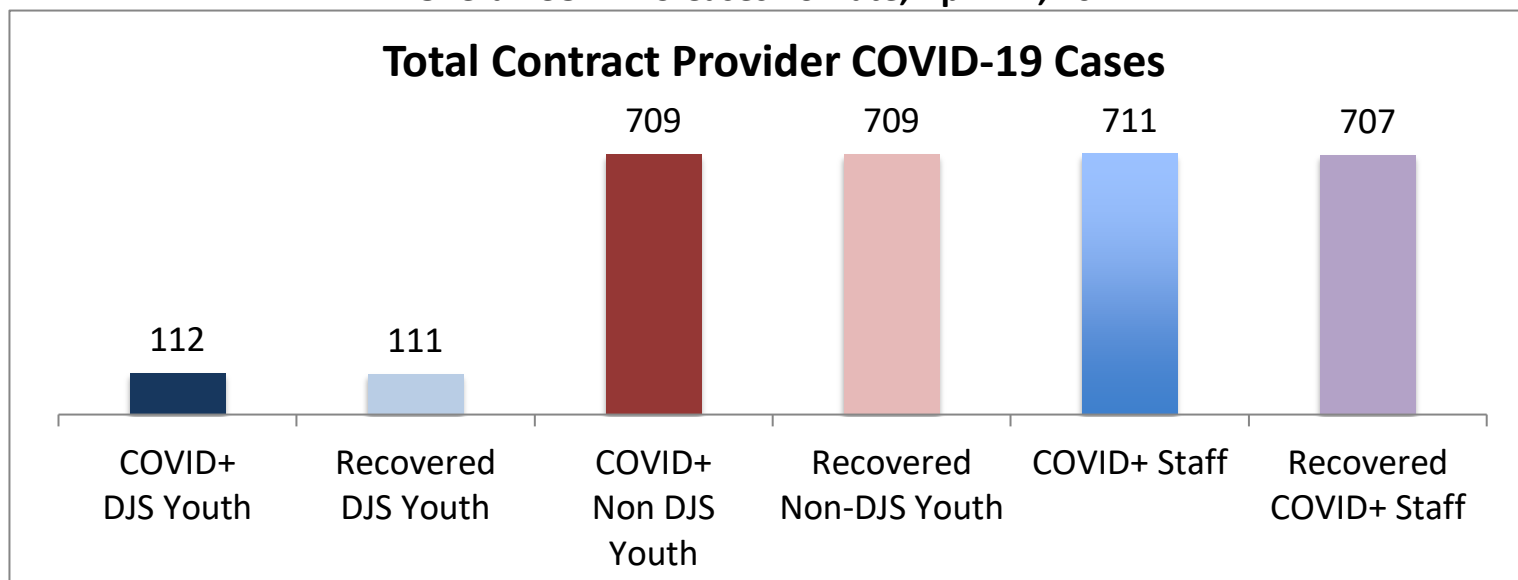


Overall COVID19 Cases To Date, April 14, 2022
