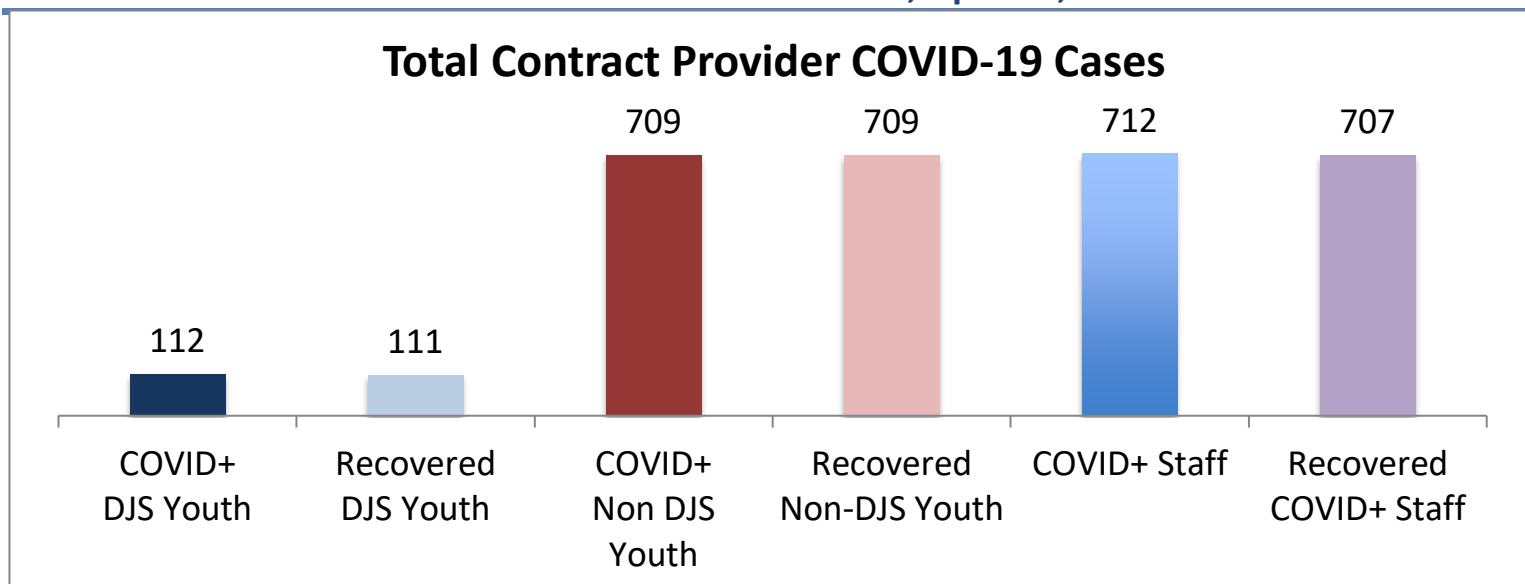


Overall COVID19 Cases To Date, April 15, 2022
