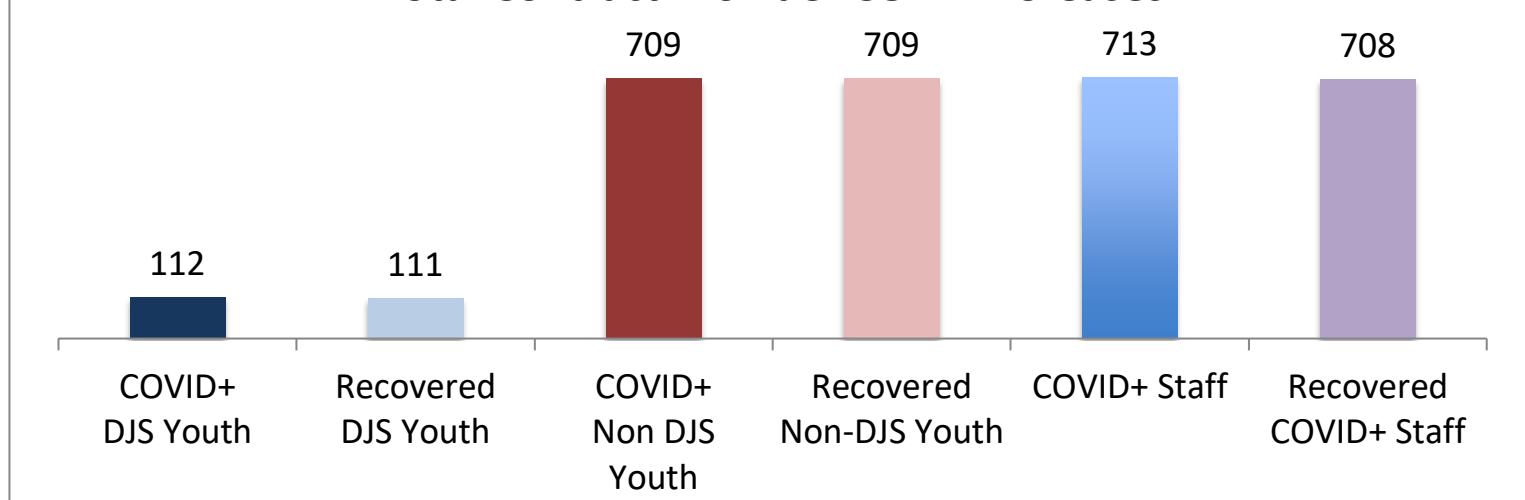


**Overall COVID19 Cases To Date, May 10, 2022**
