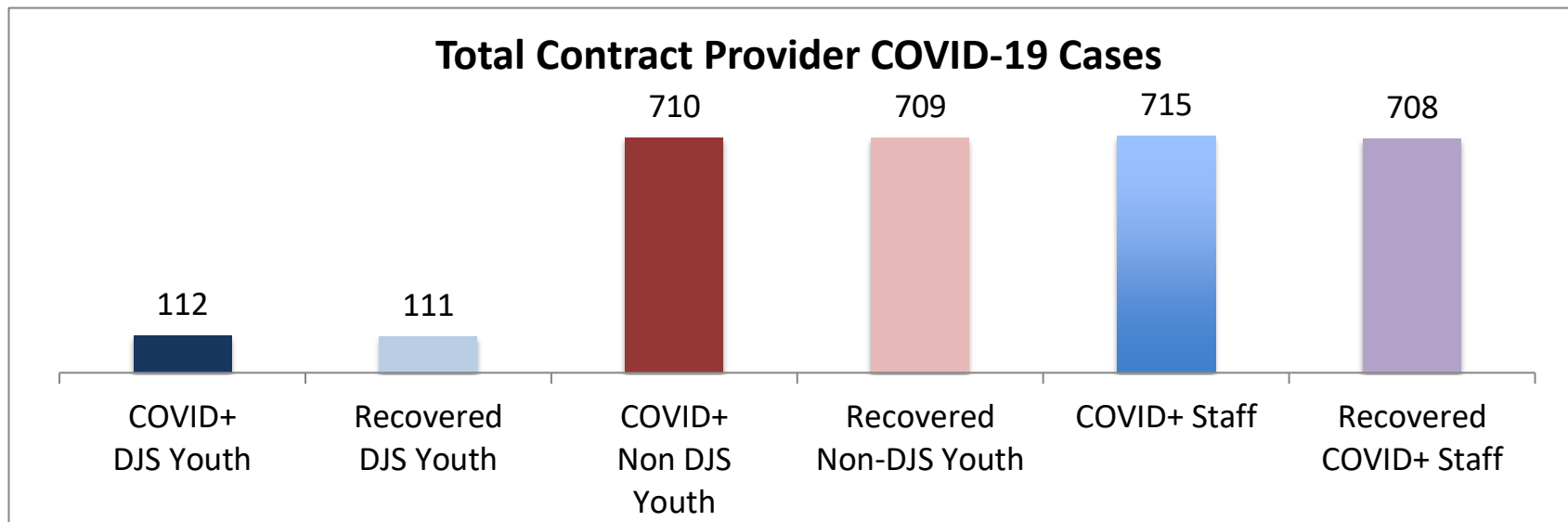


Overall COVID19 Cases To Date, May 13, 2022
