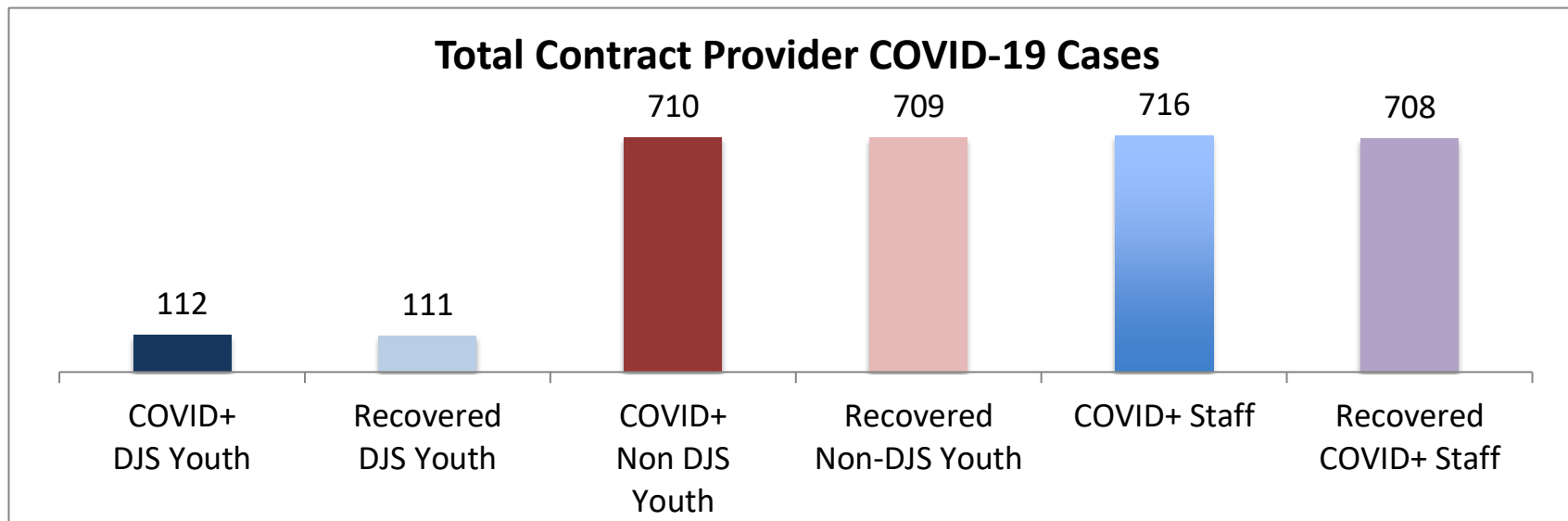


Overall COVID19 Cases To Date, May 16, 2022
