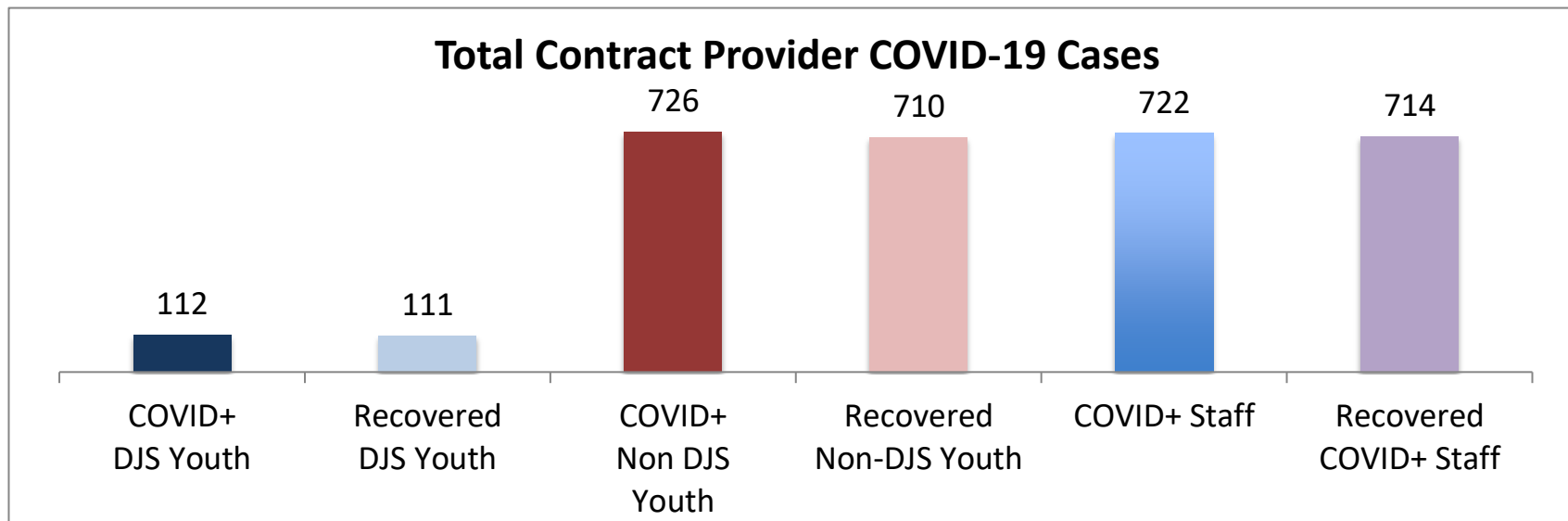


Overall COVID19 Cases To Date, May 27, 2022
