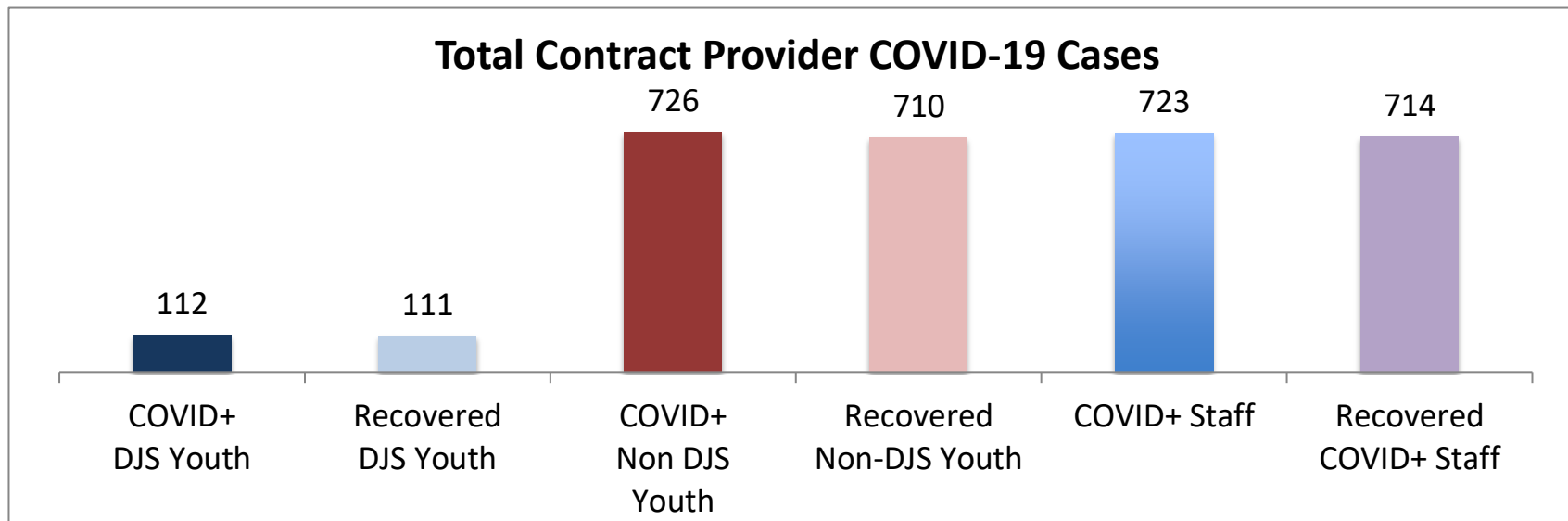


Overall COVID19 Cases To Date, May 31, 2022
