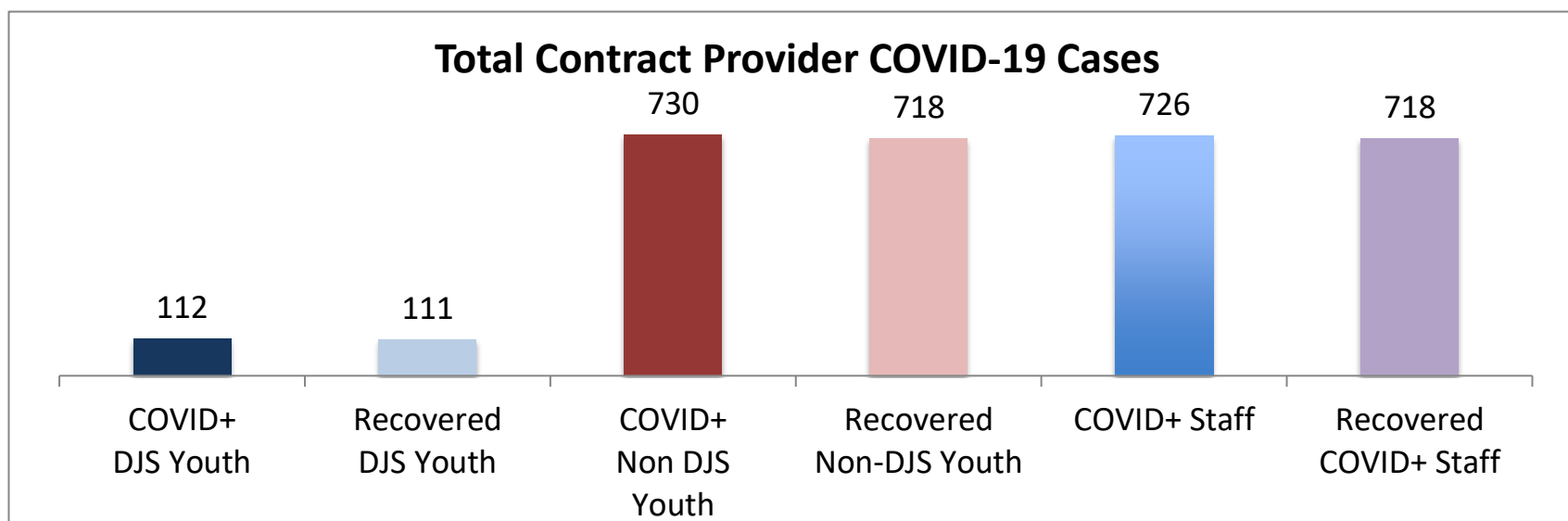


**Overall COVID19 Cases To Date, June 3, 2022**
