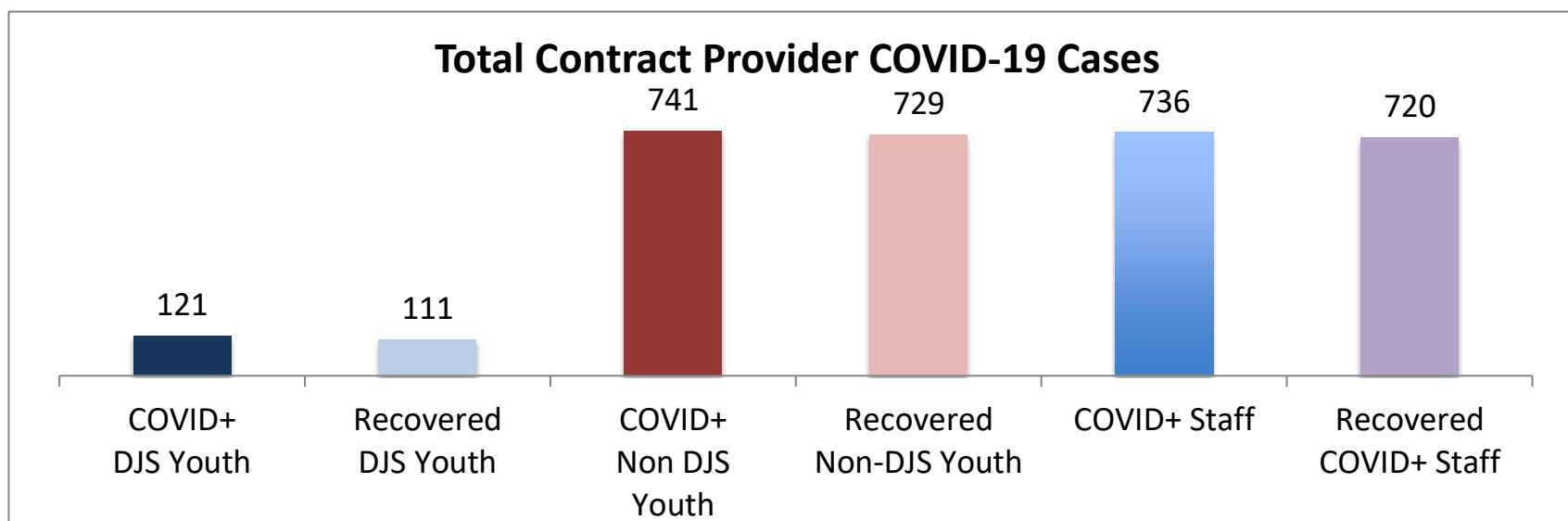


**Overall COVID19 Cases To Date, June 13, 2022**
