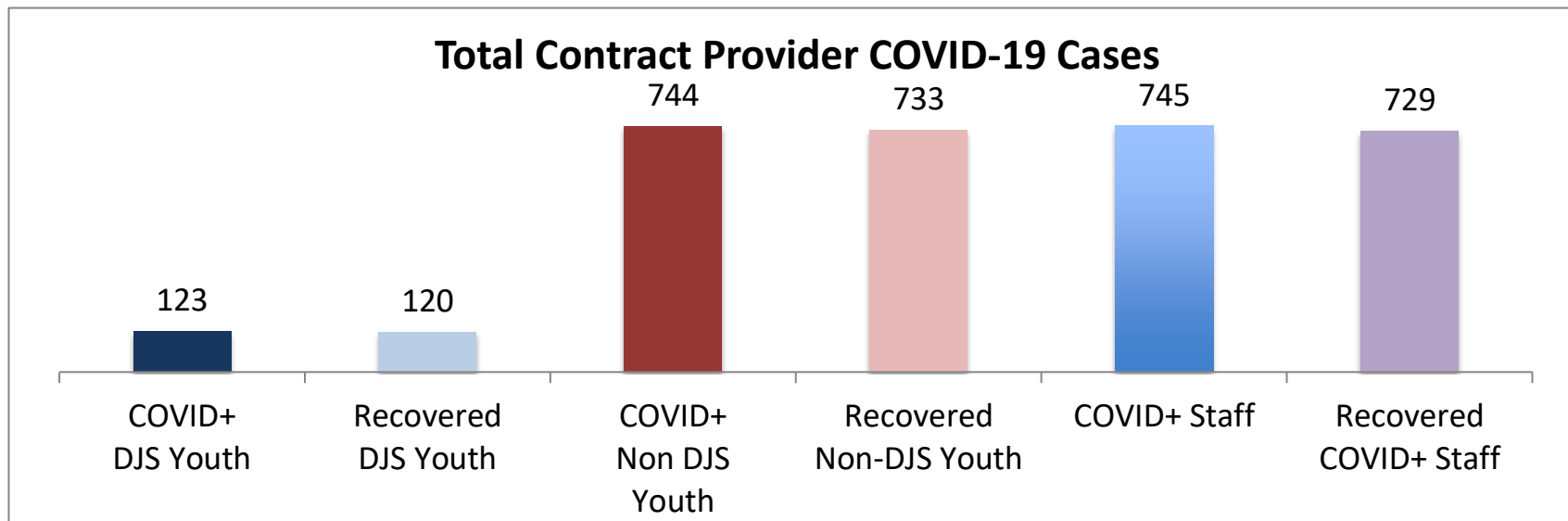


Overall COVID19 Cases To Date, June 22, 2022
