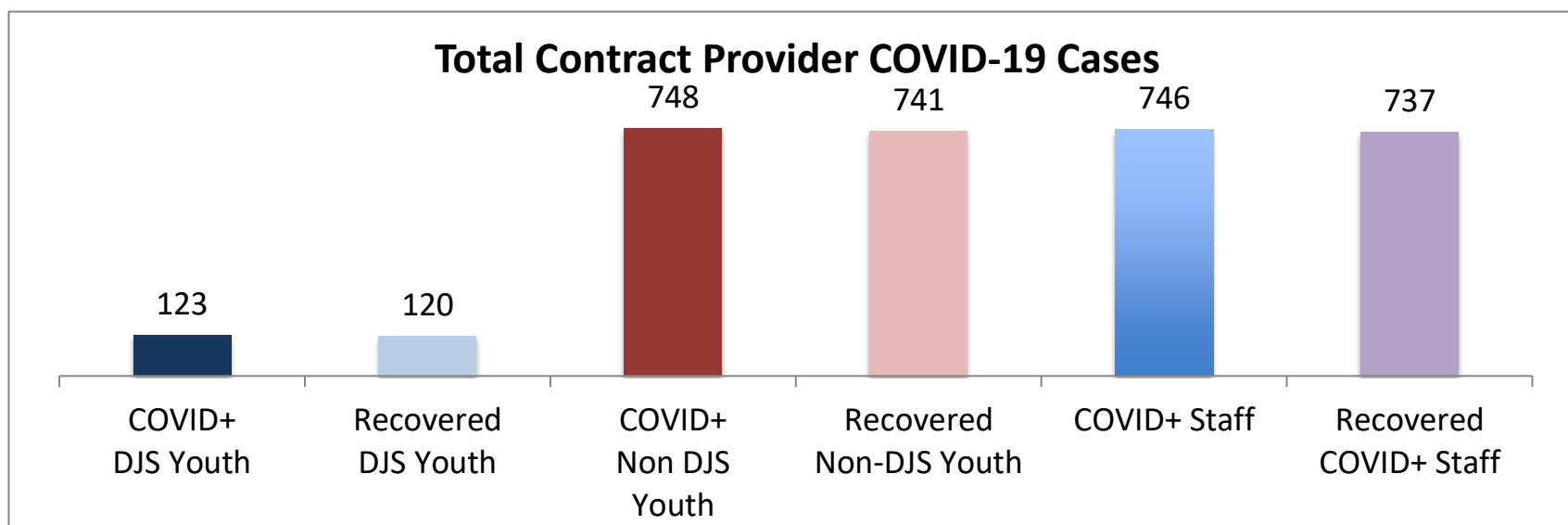


Overall COVID19 Cases To Date, June 24, 2022
