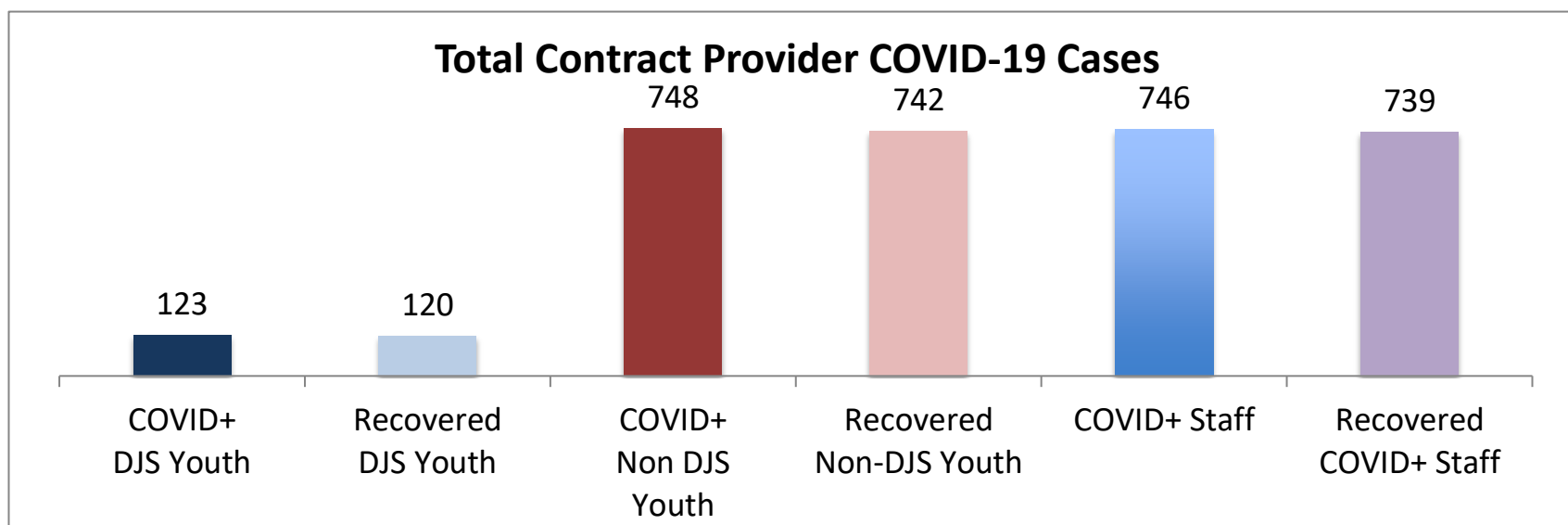


Overall COVID19 Cases To Date, June 27, 2022
