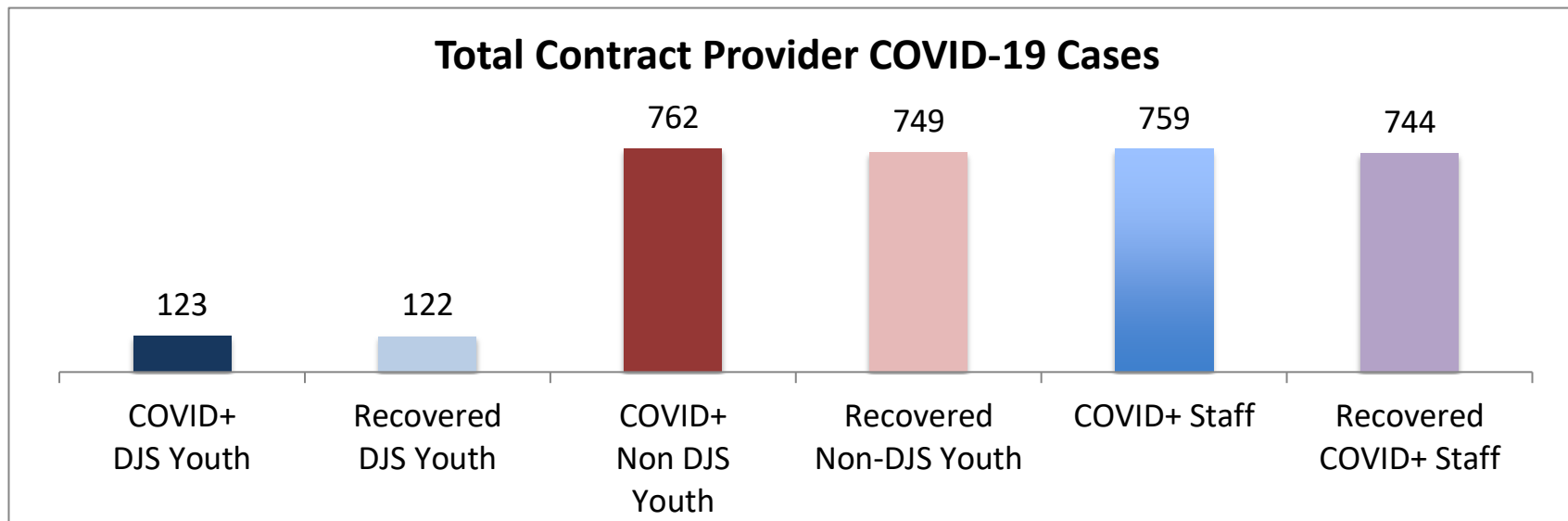


**Overall COVID19 Cases To Date, July 8, 2022**
