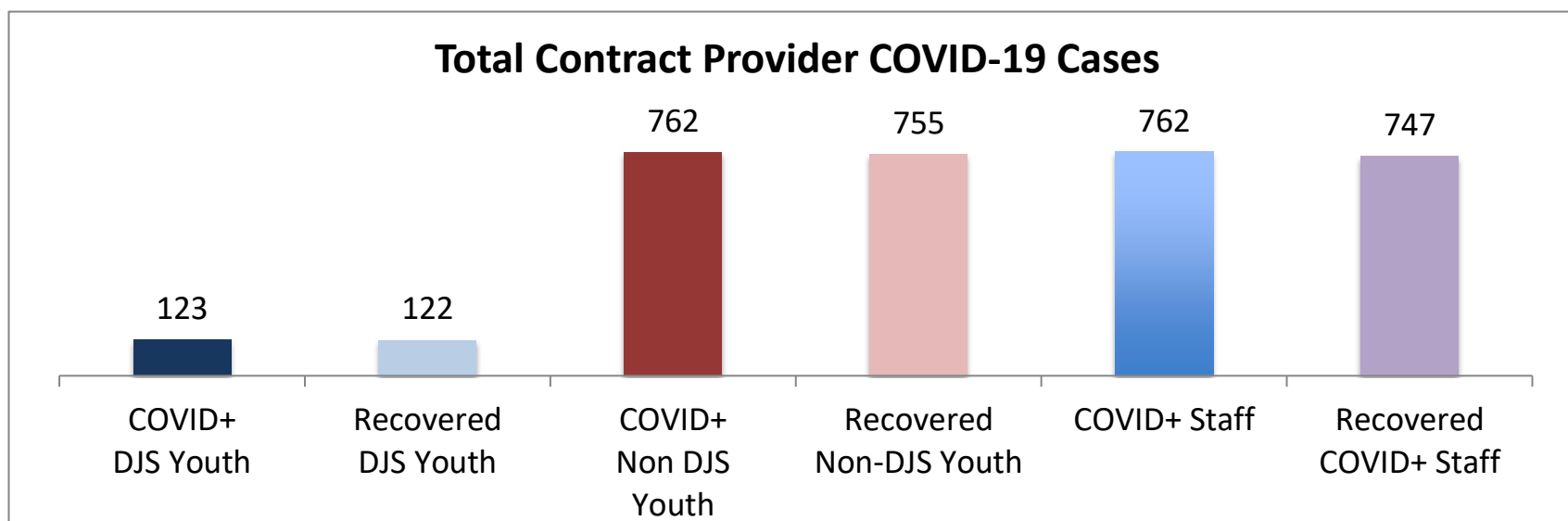


Overall COVID19 Cases To Date, July 11, 2022
