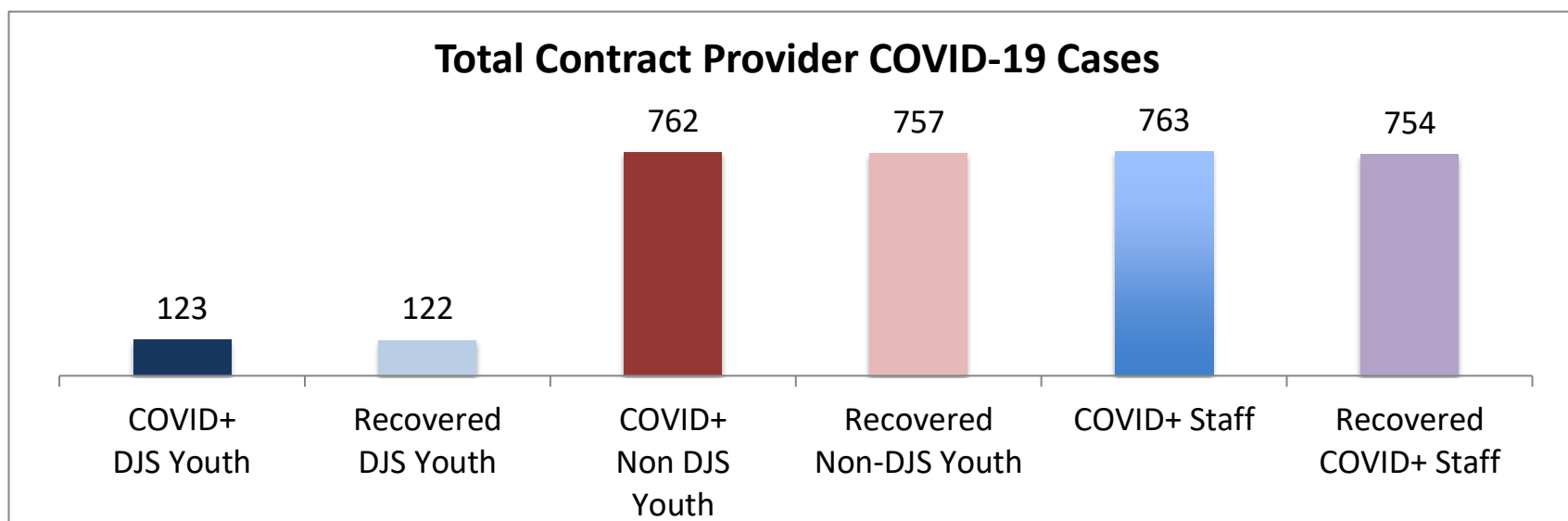


Overall COVID19 Cases To Date, July 12, 2022
