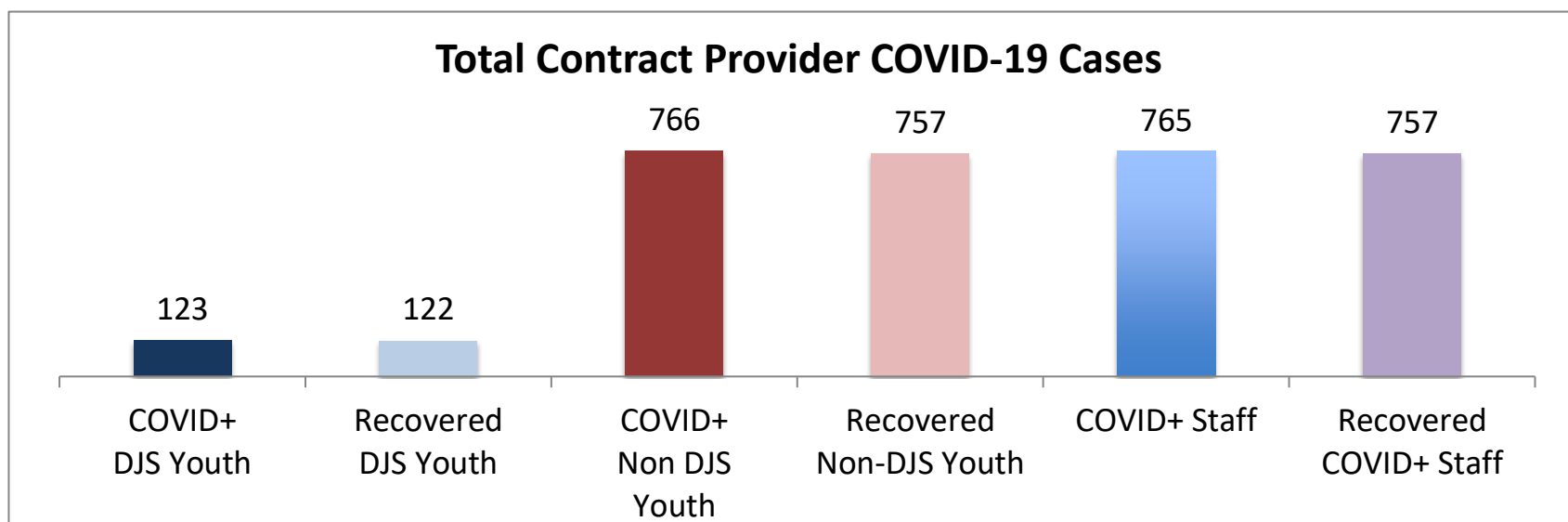


Overall COVID19 Cases To Date, July 15, 2022
