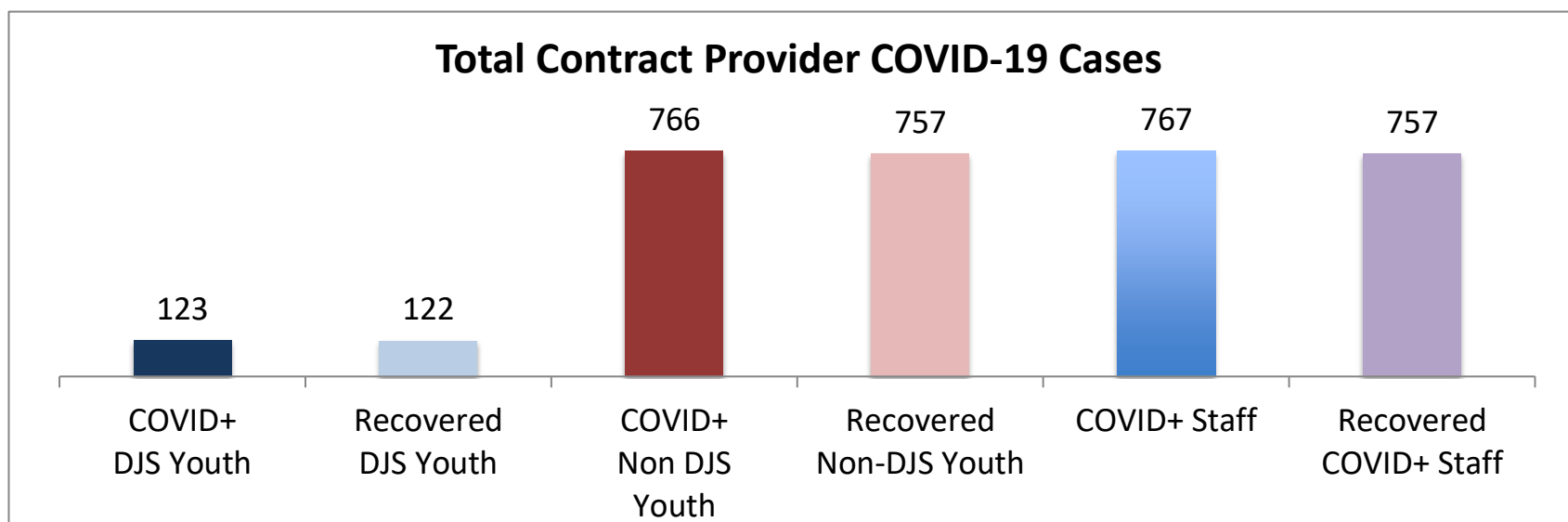


Overall COVID19 Cases To Date, July 18, 2022
