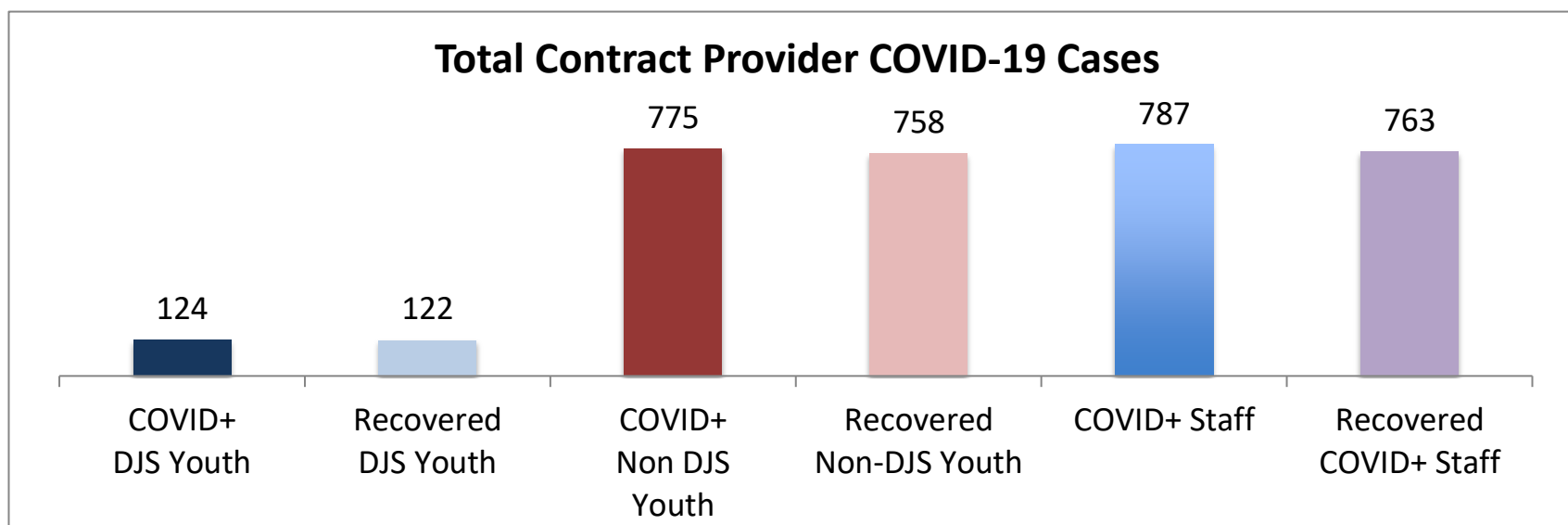


**Overall COVID19 Cases To Date, August 2, 2022**
