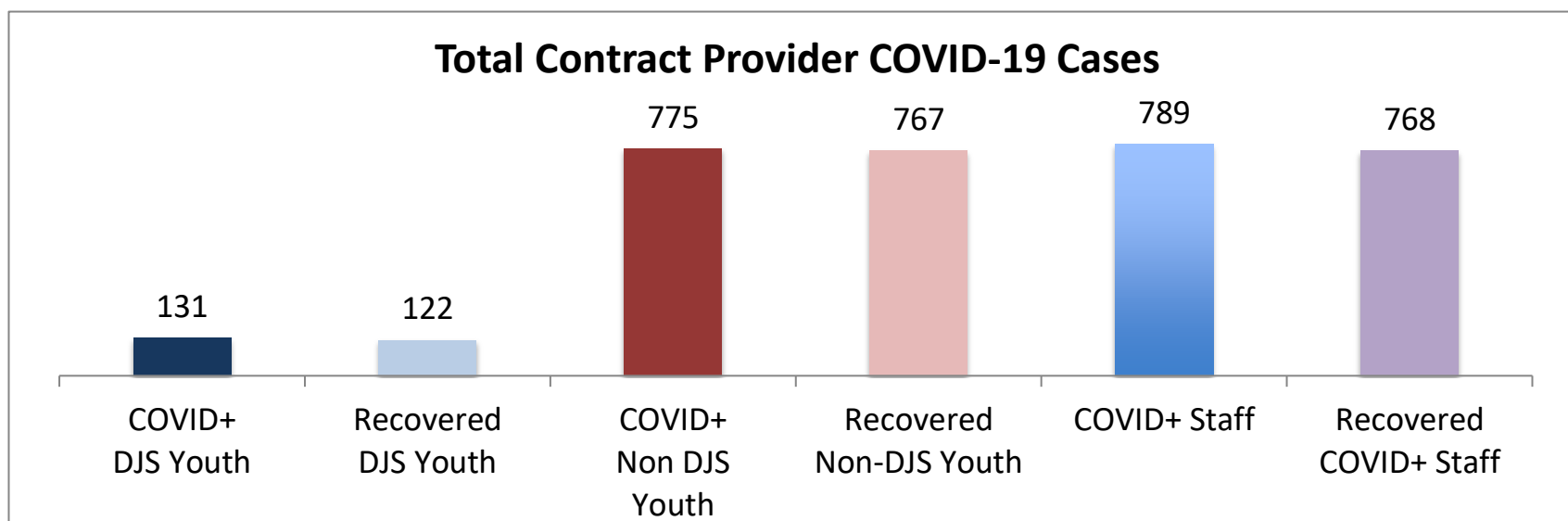


**Overall COVID19 Cases To Date, August 10, 2022**
