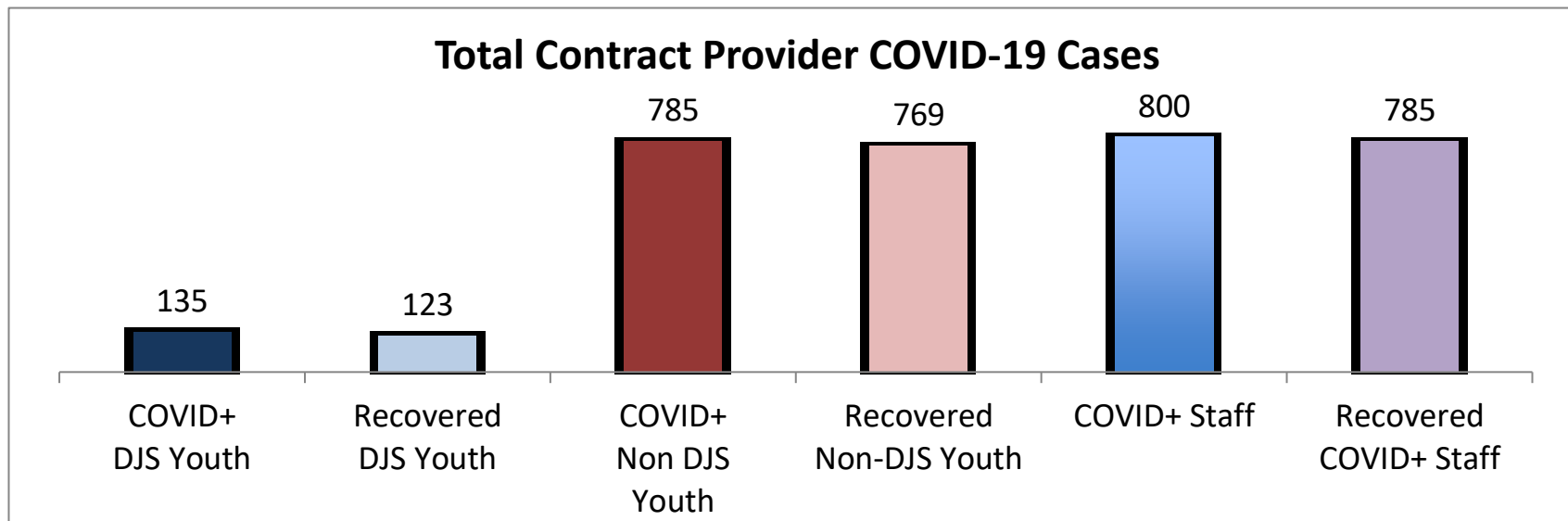


**Overall COVID19 Cases To Date, August 30, 2022**
