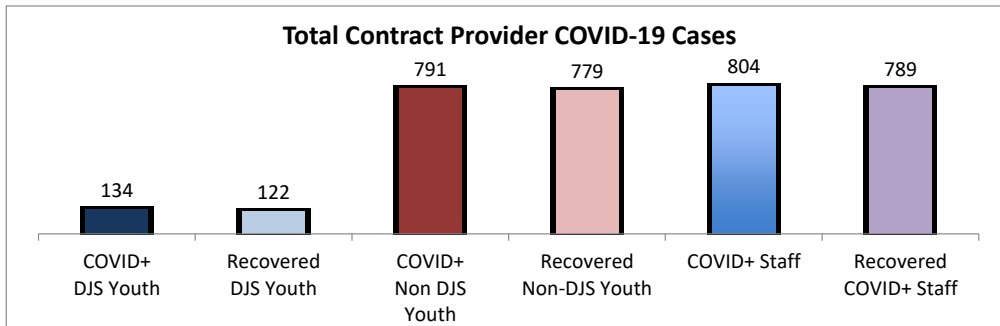


Overall COVID19 Cases To Date, September 12, 2022
