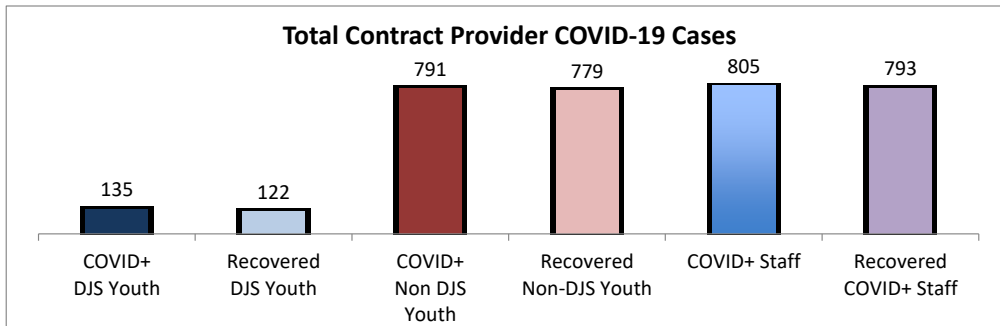


Overall COVID19 Cases To Date, September 15, 2022
