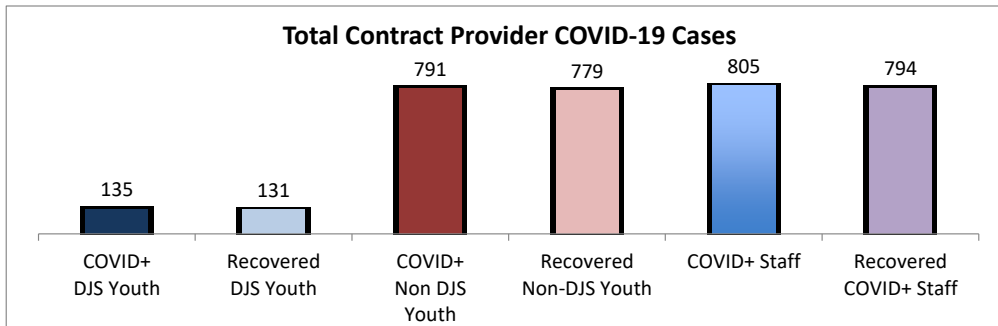


**Overall COVID19 Cases To Date, September 16, 2022**
