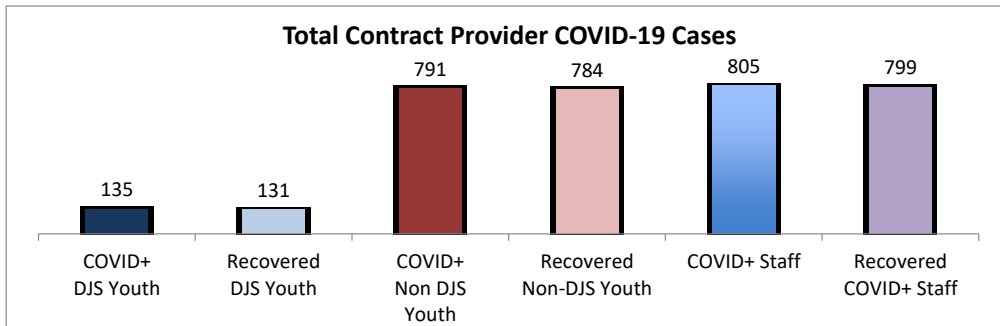


Overall COVID19 Cases To Date, September 19, 2022
