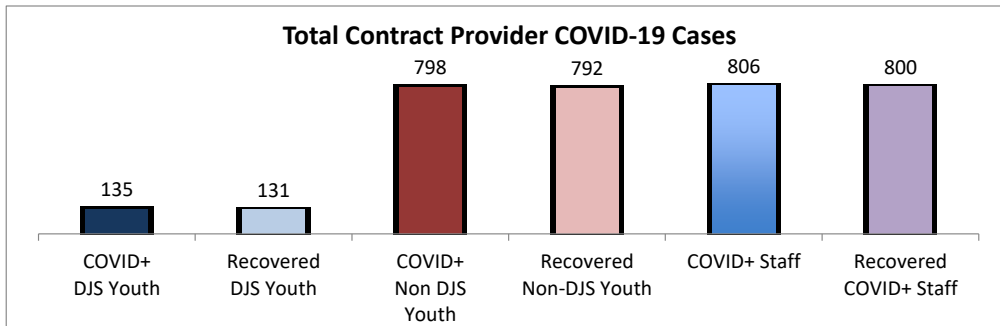


Overall COVID19 Cases To Date, September 30, 2022
