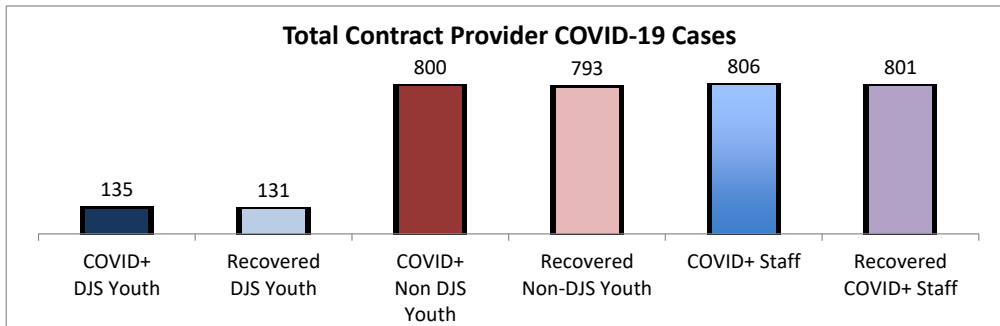


Overall COVID19 Cases To Date, October 6, 2022
