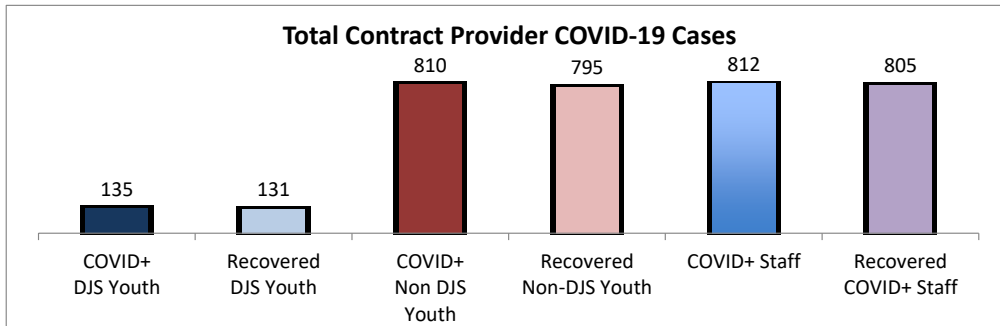


**Overall COVID19 Cases To Date, October 24, 2022**
