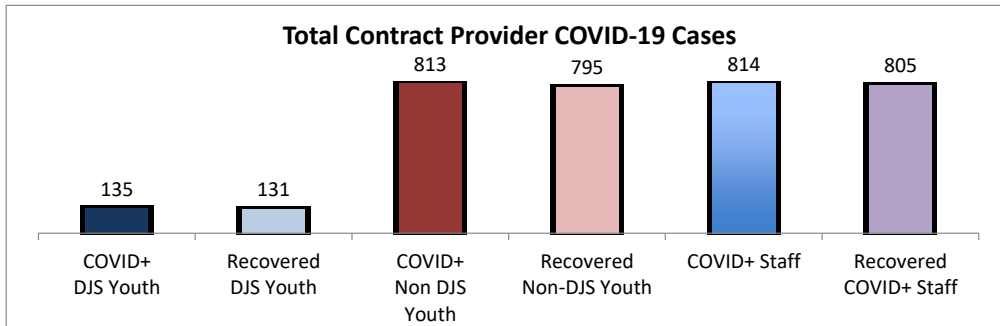


Overall COVID19 Cases To Date, October 25, 2022
