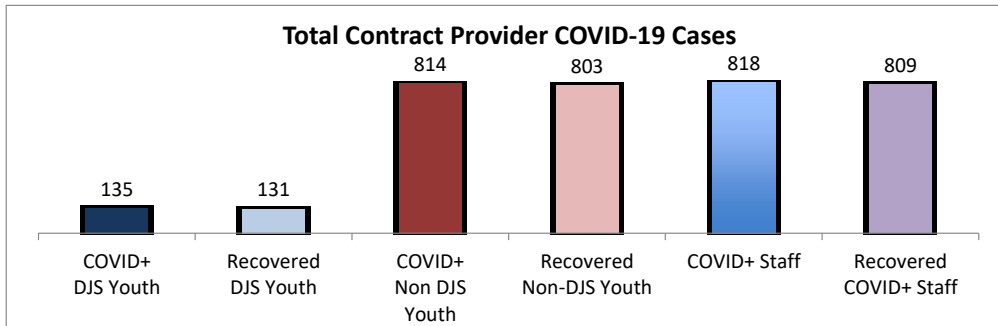


Overall COVID19 Cases To Date, November 7, 2022
