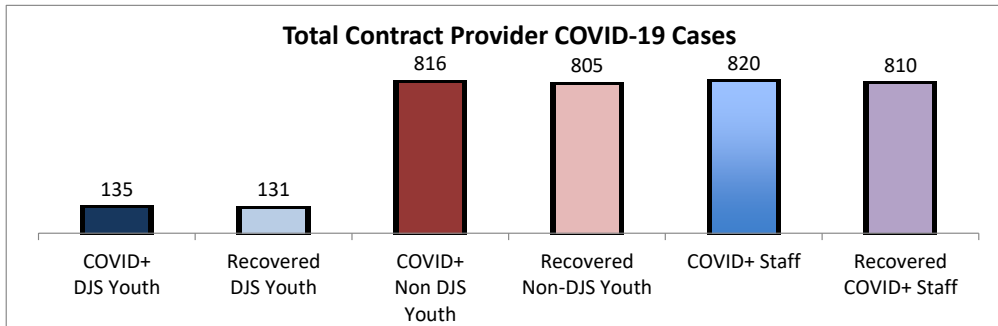


Overall COVID19 Cases To Date, November 14, 2022
