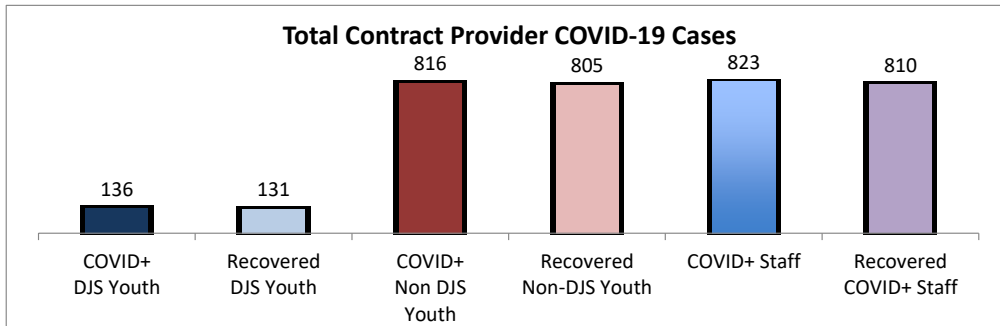


Overall COVID19 Cases To Date, November 15, 2022
