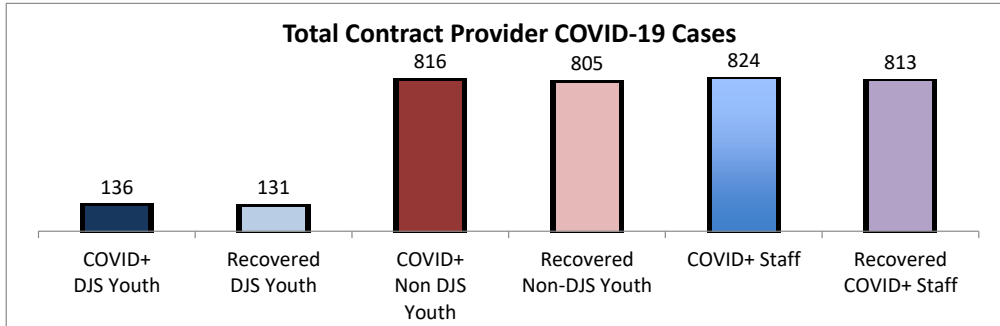


**Overall COVID19 Cases To Date, November 21, 2022**
