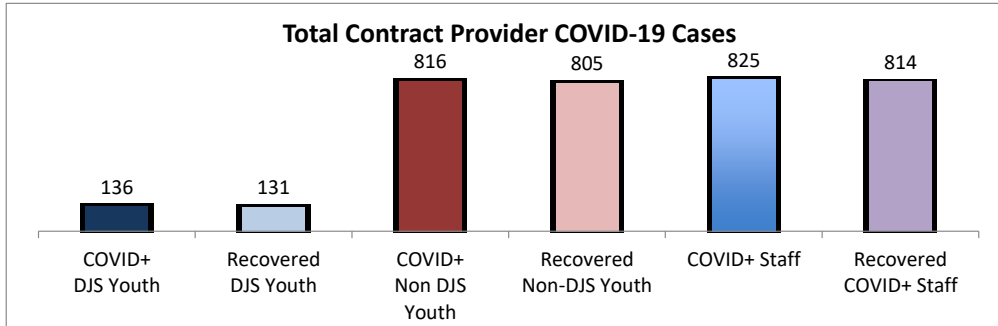


Overall COVID19 Cases To Date, November 28, 2022
