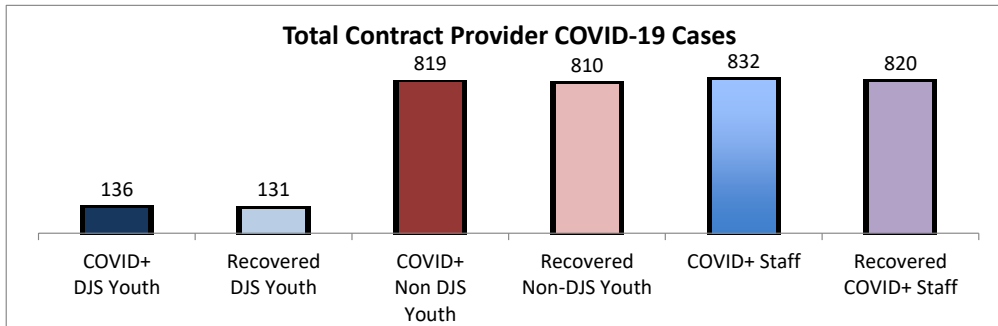


**Overall COVID19 Cases To Date, December 5, 2022**
