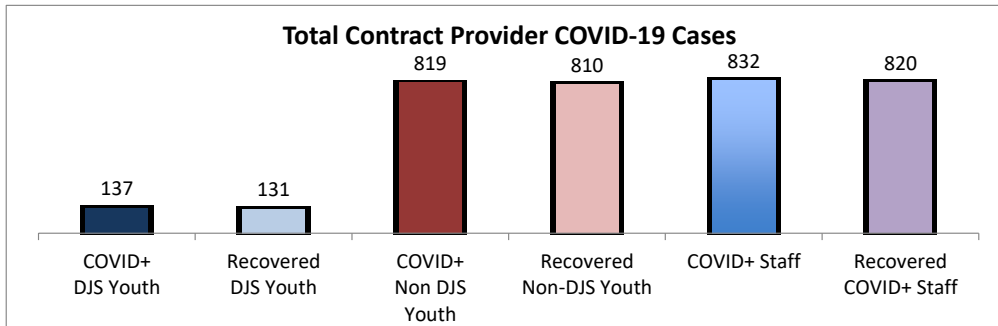


**Overall COVID19 Cases To Date, December 6, 2022**
