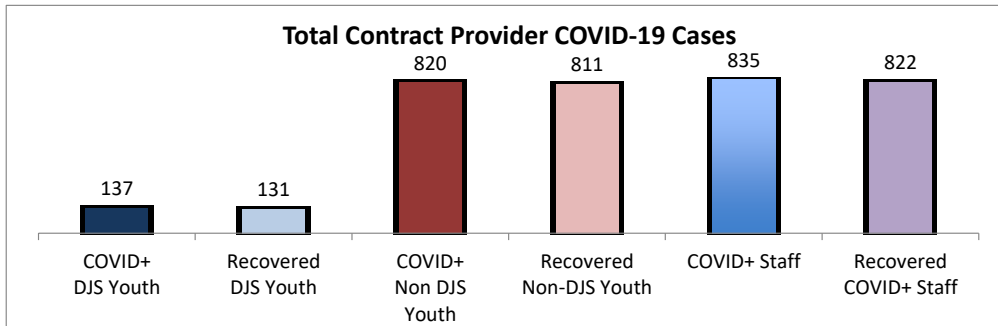


**Overall COVID19 Cases To Date, December 8, 2022**
