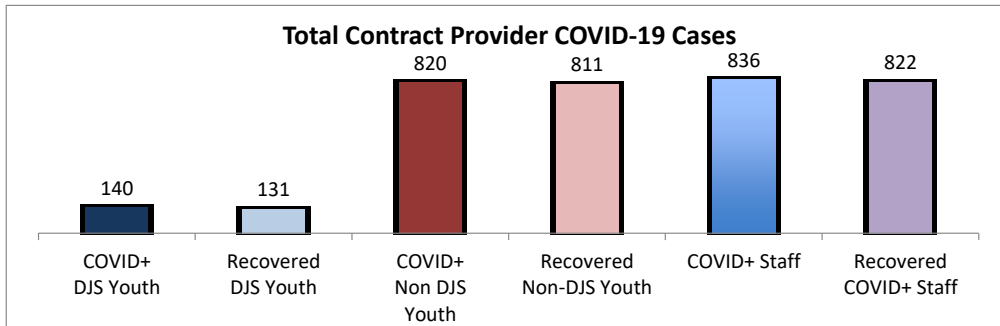


Overall COVID19 Cases To Date, December 12, 2022
