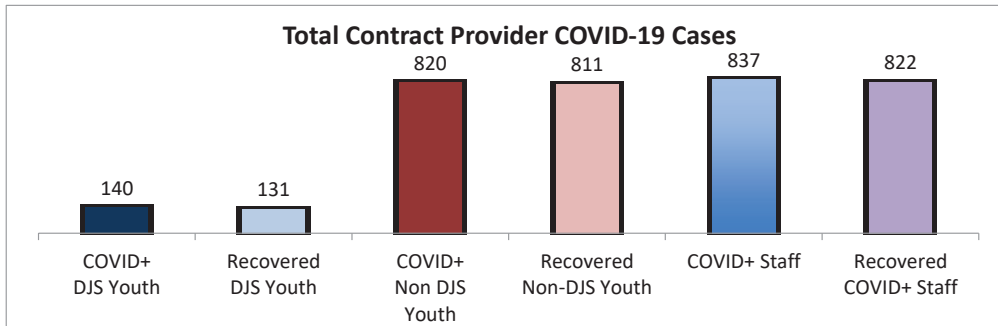


Overall COVID19 Cases To Date, December 13, 2022
