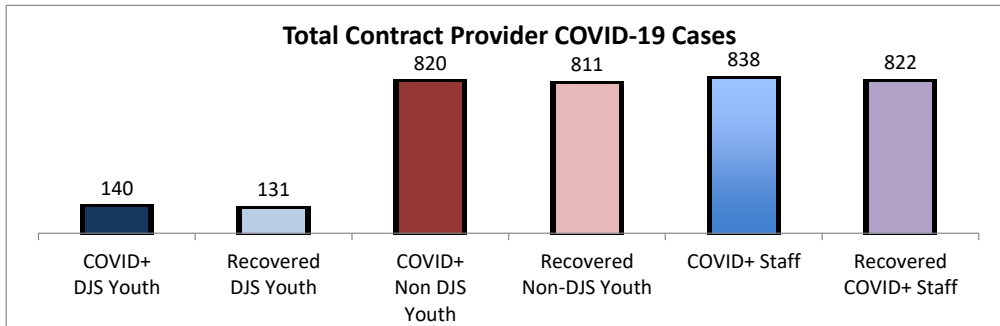


Overall COVID19 Cases To Date, December 15, 2022
