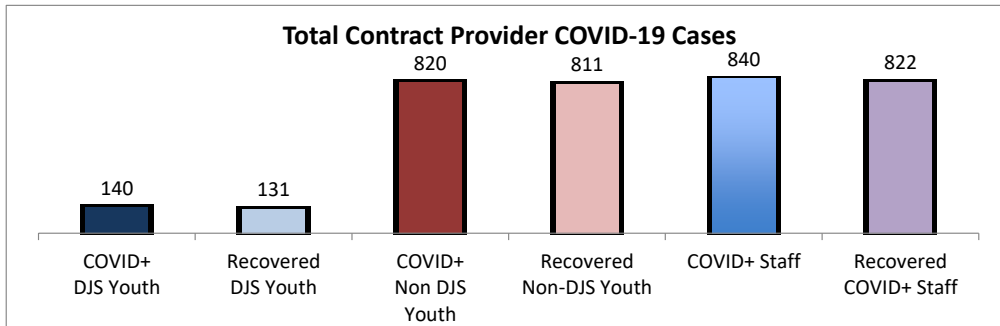


Overall COVID19 Cases To Date, December 16, 2022
