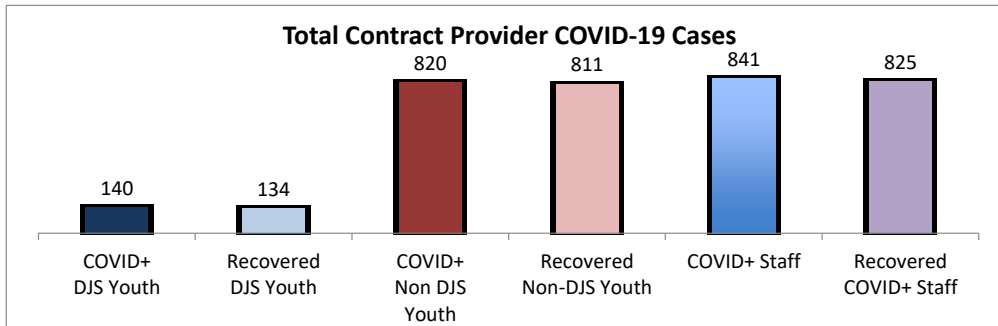


Overall COVID19 Cases To Date, December 19, 2022
