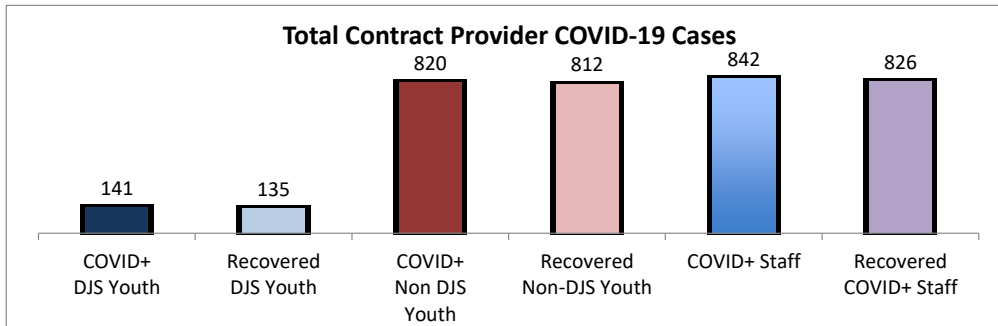


Overall COVID19 Cases To Date, December 21, 2022
