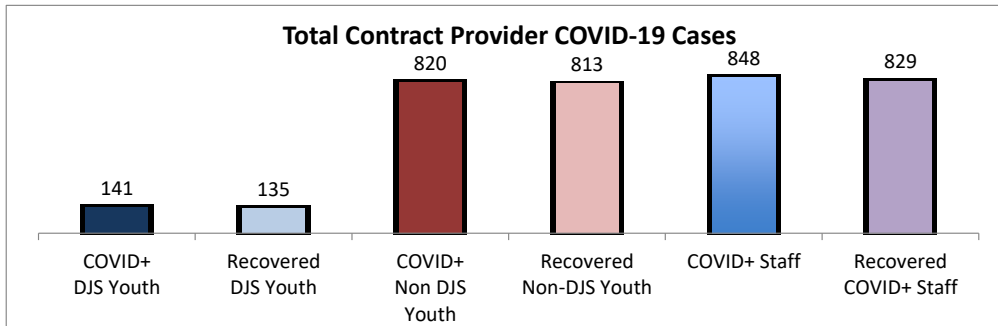


Overall COVID19 Cases To Date, December 29, 2022
